## **Terms and Conditions of Sale**

**If you are not willing to abide by the following Terms and Conditions, or if you are unwilling to personally accept responsibility for your own actions, personal liability and well being, please do not make use of the services of Island Dreams.**

**Island Dreams, Inc., dba Island Dreams Travel,** will provide services based on these Terms & Conditions. The Clients' acceptance of verbal or written confirmation, payment of a deposit, or payment for any travel services, constitutes acceptance of these Terms and Conditions as a clear and binding agreement.

**Deposit & Final Payment:** A deposit payment in the amount of 1/3 of the total invoice is required to confirm a booking. Unless otherwise noted, full payment for all services is required 60 days prior to commencement of travel.

**Documentation:** For travel outside the USA, each traveler must have a valid Passport. Requirements may change. Check status at <http://travel.state.gov>

**Children:** Minors leaving the USA for Mexico MUST have a passport, birth certificate, and written notarized permission to travel from any of the parent(s) not traveling with the child.

**Scuba Divers must have valid Diver Certification Card.** Only certified divers may participate in scuba diving activities. Divers must accept full and complete responsibility for themselves, their actions, and their equipment. Divers are expected to supply, or rent, their own gear. The only gear routinely supplied with dive packages are tanks, weights and weight belt.

**Service Fees:** All bookings made within 7 business days of initial departure will be charged a \$35 per booking late fee. There will be a charge of \$25 per instance for all client-requested changes requiring a new voucher to be issued. Airline tickets will be charged a flat fee of \$40 per ticket issued.

**Waiver Required:** Be advised that the dive operation, and Island Dreams, require that all divers complete a

waiver of liability prior to engaging in diving activities. Those who do not sign the waiver(s), will not receive diving services.

**Cancellation must be received in writing.** Be advised that the client is responsible for any and all penalties assessed by the resort, dive operator, airlines, and other service providers. In addition to these penalties, cancellations made 60 or more days prior to departure will be refunded less a \$100 per person Island Dreams' service fee. Cancellations within 60 days of departure are subject to a \$300 per person Island Dreams' service fee. Cancellations made less than 30 days prior to departure are fully non-refundable.

**NOTE: Additional penalties from resorts and/or airlines may also apply.** Airline tickets are frequently non-refundable. Price, choice of hotel, other services, scheduling, etc. are subject to availability and are subject to change. **No refund or transfer of any unused portion of the travel package is permitted.**
